Any member of the Human Rights Corps have no right to take any case directly and have no authority to do raid/investigation/enquiry at anywhere or question anyone without the prior authorization from the National Advisory Committee. Written complaint only can be accepted and will be forwarded to legal authorities through proper channel.
